Oslo, 9 April 2021: Reference is made to the stock exchange notice by Aker Clean Hydrogen AS (the "Company") on 11 March 2021 where the Company announced the beginning of the stabilization period following a private placement of new shares in the Company (the "Private Placement") and admission to trading of the Company's shares on Euronext Growth.

Carnegie AS (the "Stabilization Manager") has informed the Company that the stabilization period has ended. Stabilization activities have been undertaken between 11 March 2021 and 9 April 2021 (the "Stabilization Period") and comprise a total of 28,125,000 shares in the Company, purchased at an average price of NOK 14.4022, as further set out in the attached end of stabilization notification.

As a consequence of the stabilization activities taken, the Stabilization Manager has informed the Company that it will not exercise the greenshoe option and shall redeliver the 28,125,000 shares purchased through stabilization transactions to Aker Horizons Holding AS, in accordance with the terms of the share lending agreement between the parties.
